## What is the purpose of my role?

Working with the Assistant Chief Commissioner (Outdoor Adventure), you are responsible for collaborating on the implementation of strategic aspects that support Target Sports activities within the branch.

Ensure our teams deliver outstanding experiences and support to youth members and leaders as they grow and develop through active participation in the Youth Program. Provide expert support and guidance in the delivery of training for Target Sports activities across the Branch, in alignment with National and Branch directives.

### How do I fit in?

The BC Target Sports forms part of the wider Outdoor Adventure Team and is required to work across all areas of the association and with head office staff depending on the tasks being carried out.

# How much time is required?

The time required for this role will vary depending on the specific responsibilities and priorities at any given time. As a volunteer manager within Scouts SA, you can expect to be involved in a wide range of activities and projects which may require a significant time commitment.

- Demonstrated commitment to the values and principles of Scouts Australia.
- Flexibility and adaptability to changing circumstances.
- Ability to work collaboratively with diverse groups and teams.

#### **Training Requirements**
